# Water Mains Installation Request Form

Article 76 – Water and Sewerage Services (Northern Ireland) Order 2006

This form should only be submitted where

a) you have received a watermain layout from NIW AND

b) you have applied for an Article 161 Agreement for the location covered by this WInst.

If a watermain design has not been completed you should apply for a Watermain Requisition Internal to Site (WRI-A076).

- **Submit a maximum of 3 months and a minimum of 6 weeks before installation is required.**
- **All parts indicated as mandatory MUST be completed including the date that the site will be ready for the installation of the watermain. Please ensure full completion in order to avoid a delay in the process, due to further clarification being required.**
- **Separate Installation Request Forms are required for each section of main required at any time.**
- **Do not request the main unless you are ready for the installation as per part 4 “Standard Conditions for the Provision of Watermains to a New Development” of the submitted application form WRI-A076.**
- **If however NIW have to abort the Installation at the mutually agreed time due to the site not being ready, you will be charged for an aborted visit in accordance with the charges set out in the current Scheme of Charges.**
- **A copy (or portion) of the approved watermain design MUST be submitted with each request clearly indicating the section of main required. Failure to do so will result in the application being returned or delayed.**
