LEAKAGE ALLOWANCE APPLICATION

Please read the following guidance notes before completing this application:

- Please complete **ALL** relevant sections of this application – incomplete applications will not be accepted.
- Do not return your application until all repair work has been carried out.
- All leaks must be repaired within **4 weeks** of the date you first discovered the leak or were made aware of a potential leak (whichever is earlier). This could be, for example, on receipt of a letter from NI Water advising of high consumption or a bill showing consumption which is higher than normal.
- Your Leakage Allowance Application must be made within **6 weeks** of the date of repair of the leak. In circumstances where the leak has been repaired before the impacted bill has been issued, your application must be made within 6 weeks of the bill date.
- Where requested, you **MUST** provide a plan diagram showing the layout of the supply, including the pipe work, direction of flow, the meter location and everything supplied, e.g. domestic and non-domestic buildings, cattle troughs, outside taps etc.
- Incorrect or inaccurate information could prejudice your eligibility for an allowance.
- Northern Ireland Water reserve the right to carry out a site inspection to confirm the information supplied within your application.

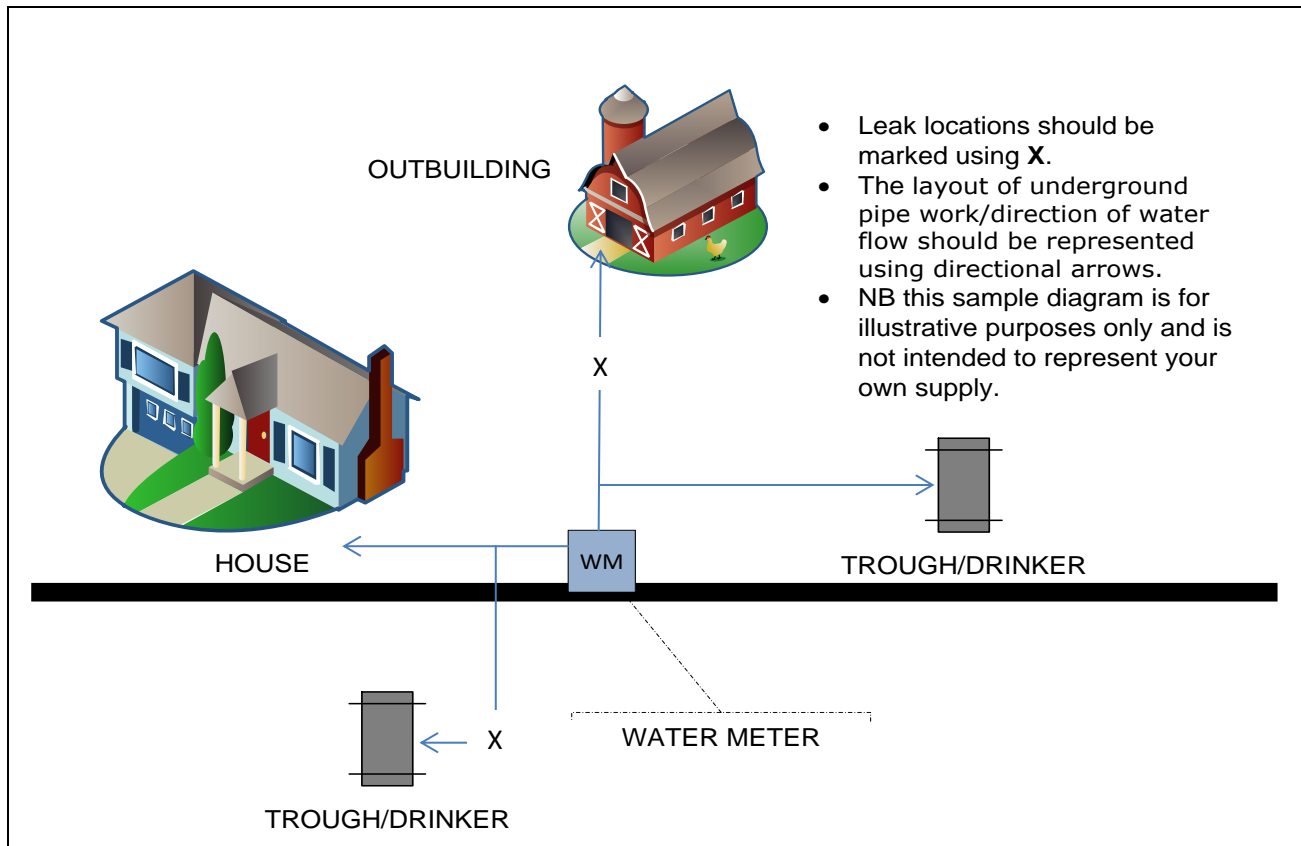
